NOTICE OF PLANNING COMMITTEE MEETING OF THE PARISH COUNCIL

The members of the Planning Committee ARE HEREBY SUMMONED to attend the Planning Committee Meeting of the Parish Council to be held at **Boughton Village Hall, Butchers Lane, Boughton on Monday 22 November 2021 at 7.00pm** for the purpose of transacting the business as set out in the Agenda of the Meeting.

Members of the Public and Press are invited to address the Committee at its Open Forum session. The Parish Clerk politely requests that anyone wishing to attend the meeting, please indicate this intention to her in advance so appropriate measures can be undertaken to comply with the Parish Council's COVID-19 measures.

COVID-19 Procedures

Since 19th July 2021, most legal restrictions to control COVID-19 have been lifted at step 4. The Government's website currently states:

- You do not need to stay 2 metres apart from people you do not live with. There are also no limits on the number of people you can meet.
- However, in order to minimise risk at a time of high prevalence, you should limit the close contact you have with those you do not usually live with, and increase close contact gradually. This includes minimising the number, proximity and duration of social contacts.
- The requirement to wear face coverings in law has been lifted. However, the Government expects and recommends that people wear face coverings in crowded areas.

With this in mind, any person attending the Parish Council meeting is asked to:-

- Sanitize your hands upon arrival <u>and</u> upon leaving the Village Hall.
- Wear appropriate layers of clothing, as all windows will be open in the Village Hall.
- Consider whether to wear a face mask, unless exempt, despite it not being a legal requirement.
- Limit close contact with those you do not usually live with.
- Consider providing contact details to the Parish Clerk upon arrival in accordance with Test and Trace requirements. Any details provided will kept in accordance with strict data protection legislation.
- Make all reasonable attempts to avoid transmission during the meeting, i.e. avoid sharing pens, documents and other objects and bring your own drinks to avoid use of the kitchen.

Under national legislation visual recordings of meetings may also be made by the public and press when they are not lawfully excluded. Your attendance at the meeting signifies your acceptance that you may be recorded.
